STUDYING PROCCCESS

Full-time form of education, 2 years.



INTERNATIONAL TRADE

- You will learn: how to analyze international trade policy, measures and instruments for regulating international trade in the context of its liberalization, the system of WTO agreements; how to present the results of the study in the form of a scientific report, article or report.



WORLD COMMODITIES MARKET CONJUNCTURE

- You will learn all about the conjuncture-price work of any unit related to foreign trade: how to summarize and analyze market information about the plume, the geographical structure of trade, pricing factors, forms and methods of trade; explore global commodity markets: identify the causes of changes in their conditions, and make forecast on this basis.



CUSTOM AND TARIFF REGULATION

- You will learn: how to use the regulatory framework for customs and tariff regulation in foreign trade; determine the HS code of goods, calculate the customs value and customs payments, fill the main customs documents - declarations of customs value and declarations for goods; navigate the basic conditions of international supplies Incoterms; how to investigate the system of commercial, transport and customs documents required in various situations (using separate methods for calculating customs value, transporting goods by different transport, declaring certain customs procedures) during customs clearance of goods, understand their content.



INTERNATIONAL ECONOMY

- You will learn theories, history and institutions of the world economy: a panorama of traditional and modern theories of international trade, the balance of payments and the exchange rate, foreign direct investment and multinational enterprises, as well as macroeconomic policies in an open economy. You will learn how to use the available methodological base for assessing current trends in the global economy.

INTERNATIONAL MONETARY RELATIONS

- You will learn the development stages of the world monetary system and the theoretical aspects of financial crises and how to overcome them; types of regulation of international monetary relations; the role of central banks and international financial organizations in the monetary regulation; the basics of international payments and international loan.

INTERNATIONAL LABOR MARKET AND MIGRATION

- You will learn the features of the demographic development in countries and its impact on the formation of labor resources; principles of the international labor market in the context of globalization; features of instruments for regulating international migration (passport systems, visa systems, citizenship).

The program also includes disciplines on intercultural communication: Professional foreign language, Theory and practice of international business communication. All disciplines of the program are interdisciplinary.
