“ In 2018, I entered the RUDN dual degree programme with La Universidad Complutense de Madrid. Previously I graduated from the Bachelor’s Degree in International Relations and often wondered how the problems of similar world processes are taught to students in other countries, whether the theoretical part, which is explained to us in Russia, coincides with that of foreign universities. This program allowed me to look at world processes through the eyes of Spanish students. How they understand the world’s crisis problems, how they evaluate the actions of certain politicians, etc. It was also interesting to discuss various international problems with Spanish teachers, in particular those with whom we disagree. The most interesting for me was to study Russian foreign policy in Complutense. In addition, the different approach to teaching at the two universities was also interesting. Spanish teachers gave more group projects, where several students were involved in one analytical work, which was a novelty for me. Since I now know in which direction most Spanish students think about international processes, it helps me during my work, which I probably would not have received if I had not chosen this direction for my Master’s degree (producer of Russia Today en español TV channel). The most attractive thing about choosing a master’s degree was that after defending a master’s thesis in two languages you get a master’s degree in two countries at once and, accordingly, two diplomas.

This is an incomparable experience. We got acquainted not only with the Spaniards’ view of international politics, but also with Spain itself and its inhabitants! We saw how different cultures coexist within the same country (Catalonia, Basque Country and others). During my studies in Madrid I had a chance to do an internship at the representative office of Rossotrudnichestvo in the “Russian Center of Science and Culture in Madrid”, where the work of the diplomatic mission was studied in practice.

I am very glad that I had a chance to study at Complutense University and at the same time at RUDN. The dual degree program is the best option to gain experience from the leading universities of the two countries. I recommend it to those who not only want to get an opportunity to study abroad, but also to become in demand on the international labor market. ”
