# **PROGRAM ADVANTAGES**

- The knowledge gained as a result of an interdisciplinary approach allows graduates to work in any area of international legal regulation.
- The variety of classroom activities of a practice-oriented nature contributes to the graduates' ability development to understand difficult situations, which gives them advantages in hiring and in career growth.
- The study group, consisting of representatives from different regions of the world, gives the educational process an international and more interactive character, making it rich in content and broad in spatial coverage and studied issues.
- Special courses of the programme built on modules, make it possible to attract a wide range of well-known domestic and foreign theorists and practitioners in various segments of the programme as lecturers.
- During the implementation of the master's programme, a unique library on international space law was created on the basis of the Department of International Law of the RUDN University.
- ✓ The curriculum is designed in such a way that each specialty discipline takes into account intersectoral relationship when solving problems on the agenda of the UN and its specialized agencies, for example, the launch of space objects from offshore platforms, which requires professional knowledge of international space law, international air law and international maritime law. Also the development of material on the Arctic, which implies the availability of comprehensive knowledge of international

environmental law, international law of the sea, international legal protection of the rights of indigenous peoples and international space law in terms of satellite communications for rescue in accidents or the fight against international terrorism and the observance of human rights in the course of this fight, affecting the law of international security, the fight against international crimes, the observance of human rights and related problems, such as the legitimacy of secret prisons or prisons like the Guantánamo prison, the institution of extradition, ensuring the right to judicial protection and guarantees of the impartiality of the court. Or the international legal obligations of states on the activities of transnational corporations on the territory of another state, leading to environmental damage and violation of the rights of indigenous peoples. Or what are the obligations of states to protect the embassies and consulates of other states in the event of a threat from demonstrators, and what legal means can the accrediting states apply if the host state fails to fulfill these international obligations?
