- ✓ Education involves obtaining two diplomas (RUDN University and ENU named after L. Gumilyov)

STUDYING PROCESS

ACTUAL PROBLEMS OF CRIMINAL LAW AND PROCESS (RUDN)

- Controversial aspects related to the criminal law, classification of crimes, exemption from criminal liability and punishment, responsibility for certain types of crimes.



THEORY OF EVIDENCE (RUDN)

- Genesis of evidence, legal and organizational basis for the collection, verification and evaluation of evidence in criminal proceedings; provisions on criminal procedural evidence in the near and far countries; classification and types of evidence.



THEORY OF CRIMINAL LAW AND PROCEDURE (RUDN)

- Principles, methods and means of conducting research in the field of criminal law and criminal procedure; criminal law concepts and institutions: criminal law, crime, corpus delicti and its types, complicity in a crime, punishment, exemption from criminal liability and punishment, general rules for qualifying crimes; criminal procedural concepts, properties of criminal proceedings, its relationship, patterns of occurrence, functioning and development as a social and legal phenomenon.



CRIMES IN THE FIELD OF ECONOMIC ACTIVITY (RUDN)

- The methodology for identifying criminal law problem situations, assessing criminal law risks in the field of economic (business and other) activities, practical skills in conducting verification and investigatory actions, organizing the economic crimes investigation and interaction with operational and control structures, skills of working with regulatory legal acts of various law branches to solve a legal problem, resolving conflict situations.



PROBLEMS OF IMPROVING THE LEGISLATION ON LIABILITY FOR CRIMES AGAINST PROPERTY (ENU NAMED AFTER L. GUMILYOV)

- Issues of improving the effectiveness of criminal legal protection of property from crimes committed by fraud or breach of trust; various kinds of recommendations aimed at improving the constructions of criminal law on liability for the acts in question and optimizing the practice of their application. Problems of improving criminal law on liability for crimes against property committed by fraud or breach of trust.



SPECIAL CRIMINAL TRIAL PROCEEDINGS (ENU NAMED AFTER L. GUMILYOV)

- Study of legislative and other normative acts regulating procedural activities within the framework of special proceedings; development of knowledge about the features of simplified and complicated procedures of criminal trial proceedings; formation of representations on the procedural status of participants in criminal trial relations involved in cases of the categories under consideration.

of the basic benefits and freedoms of minors. Professor L.A. Bukalerova has been a scientific adviser of 24 dissertations for the degree of candidate of legal sciences which were successfully defended.

She has published more than 430 scientific works, including 48 textbooks (co-authored), 19 monographs, 19 study guides, articles included in the Web of science (14) and Scopus (9) database.

Co-author and editor of the fundamental textbook “Criminal Law of Russia: General Part (with the main provisions of the General Part of the Criminal Law of Asia, Africa, Latin America)” (RUDN, 2017).

L.A. Bukalerova is a member of the editorial board of a number of journals, including: “Bulletin of the Eurasian National University named after L.N. Gumilyov” (Republic of Kazakhstan), “Legislation” (Republic of Tajikistan), “Bulletin of the VIPK MVD”, “Yearbook of Russian educational legislation”, “Problems of economics and legal practice”, “Police activity”, “Problems of economics and legal practice”, etc.



HEAD OF THE PROGRAMME

L.A. Bukalerova takes part in the work of commissions (working groups) under the Administration Office of the President of the Russian Federation, the Ministry of Education of the Russian Federation, the State Duma, and the Federation Council. Since 2009, she has been an expert of the Russian Foundation for Basic Research (Russian Humanitarian Fund), since 2013, of the Russian Science Foundation, since 2016, an expert of Rosobrnadzor, and since 2017, an expert of the Russian Academic Foundation, a member of International Association of Penal Law (IAPL) and the Union of Criminalists and Criminologists.

She was a visiting professor at the University of Toulouse, where in 2019 she gave a course of lectures on criminal, criminal procedure law and the problems of migration law in Russia.
